- b) Trustees for the time being shall have power from time to time, whenever they consider necessary to appoint additional trustees. The new trustee will have to contribute Rs. 101/- towards the corpus of the trust. The Managing Committee may remove any trustee if he or she does not comply with the conditions of the trust deed, puts indisciplined behavior or does not take part in the activities of the trust.
- c) In case of death of other trustees the Founder / Managing Committeewill appoint the new trustee on vote and discussion with other trustees provided they are qualified to be trustee as per norms of the trust deed. The nominated trustee, appointed by the Founder Trustee, will take place of Trustee and will have the similar powers.

## QUALIFICATION OF TRUSTEES:

That the first trustees or any additional trustee. That may be appointed hereinafter will cease to be so, if at any time, they suffer from any of the following disqualification:-

- a) if he or she has been found to be of unsound mind by a Court of competent jurisdiction.
- -b) if he or she is any un discharged insolvent.
- c) if he or shehas applied to be adjudicated as an insolvent and his application is pending.
- d) if he or she has been convicted by a Court of an offence involving moral turpitude.
- e) Any activity which is not in commensuration with the aims and objectives of the trust.

#### 6. OBJECTS OF THE TRUST:

The objects of the trust are as under:-

(i) To open an educational school affiliated with recognized board including but not limited to Playway, Kindergarten/ day care

(ii) To promote and run educational institutions imparting technical, modern knowledge using traditional methods based on ideology of saints and national leaders like Rabinder Nath Tagore, Mahatma Gandhi etc.

- (iii) To open, sponsor, take over, organize, establish, maintain and promote or run educational institutions i.e. schools, colleges, academies, laboratories, libraries, Nursing, Pharma, ayurvedic, Law, Medical Institutions and universities and the likes.
- (iv) To undertake publication of books/works, circulated directly or indirectly to propagate the aims and objects of the Trust.
- (v) To give aid, scholarships (refundable or non-refundable), prizes, stipends, loans or grants to any person, trust, institutions, or authority for promotion of education literature, science, fine arts, crafts, sports, cultural activities and for relief, medical treatment.
- (vi) To sponsor, open, takeover, establish, maintain, aid, promote, or run orphan homes, Sanskrit, pathshalas, houses for widows, old men and infants, dharamshala, asharams, hospitals, clinics, dispensaries, sanitariums and development projects for urban, rural, tribal, child, women and the like.
- (vii) To build, provide and maintain hostels, canteens, boarding/lodging and other convinces i.e. transport, tours for the use of institutions, and employed by institute or as may be determined by the Trust.
- (viii) To enter into any agreement with any Government or authority, municipal, local or otherwise, to obtain from such authority any rights, privileges concessions, financial or otherwise, that the Trust may deem desirable to obtain and carry out, exercise and comply with such arrangements, rights, privileges and concessions, so acquired in furtherance of the objects of the Trust.
- (ix) To hold seminars, lectures, conferences, exhibitions, concerts or other meetings/events for dissemination of knowledge and advancement of culture, fine arts, sciences, to create National spirit.
- (x) To Collaborate with any foreign institution, University, Government to facilitate the students of the institutions of the trust, to send them abroad for further studies and jobs through proper way by forming joint ventures or getting own license for the purpose.
- (xi) To organize free medical, blood donation camps and to involve in drug rehabilitation, alcohol de-addiction and AIDS prevention and care and to help the victims of flood, famine earthquake, tsunami and other natural calamities internal or external.

- To undertake and implement Rural Development Programs or other charitable Programs of the Central & State Governments and NGO's of country and abroad to (xii) promote & facilitate establishment of Village Committees, Youth Clubs and Mahila Samities in view of enabling their active participation in planning & implementation of this.
- To do all activities as defined as charitable as per the section 2(15) of the Income (xiii) Tax Act.
- To do all such other lawful acts and things either alone or in conjunction with other organizations or person as the Trust may consider necessary incidental or conducive (xiv) to the attainment of the aforesald objectives.

The trust reserves the right that with the approval of all the trustees may convert itself into a non profit company or society as per the prevalent law or may transfer any of the institute run by it to a trust, society or company (Non profit) with the similar objectives.

The Trust is hereby expressly declared to be a PUBLIC CHARITABLE TRUST and all the provisions of this declaration are to be constructed accordingly.

If any of its objects, in whole or in part of any other provision of this declaration is found to be repugnant or inconsistent with any of the said provisions as are applicable on the relevant date, such objects or provisions shall be deemed to be cancelled to the extent of such repugnance or inconsistence and if any of the objects of the Trust is found to be invalid on the ground of vagueness or any other reason by a competent authority, it shall be deemed to have not been included in the objects of the Trust so as to effect the validity of the Trust.

Nothing containing in this declaration shall be deemed to authorize the trustee to do any act which may in any way be constructed as contrary to the provisions of section 2(15), 11, 12, 12-a 13, 35CCa, 35CC, 80-G or any other relevant provisions of the Income Tax Act, 1961 or any statutory modifications thereof, and all activities of the Trust shall be carried on with a view of benefit the public at large without any profit motive for charitable purposes only as may be permissible under the provisions of the Income Tax Act, 1961 or the statutory modifications thereof, however it is a charitable objects within the meaning of the Income Tax Act, 1961.

#### POWER, RULES & REGULATIONS OF THE TRUST 7.

- The trustees shall stand possessed of the said amount of corpus and such other properties (both moveable and immovable) as may be acquired from time to time by the trust by purchase, exchange, 1) grant, subscriptions, endowment, donation, contribution or in any manner whatsoever (all of which shall be designated as "the trust properties" on the trust herein mentioned) from other persons, commercial firms, institutions, organizations, State and Central Government and Local Bodies.
- The trustees shall have power to accept donations either in cash or moveable properties either with or 2) without any special conditions attached to it provided it does not contravene Cl. 6 hereinabove.
- It shall be competent for the trustee from time to time to frame, make and enforce all such rules, 3) regulations and/or by-laws, not inconsistent with the express provisions of this trust, as the trustees may deem proper for securing and facilitating the administration and management in details of the various departments relating to the activities and affairs of the trust, and for convening, conducting and regulating the meeting of the trustees and for appointing sub-committees for the management and administration of the trust estate and also from time to time to repeal, alter, amend, reschedule or add to all such rules, regulations and by-laws and also to pass resolutions in connection with all or any of the said matter at their meeting not superseding the express provisions of this trust.

The trustees shall have power and authority to appoint or engage and at their discretion, remove, dismiss or suspend, officers, secretaries, treasures, supervisors, cashiers, accountants Clerks,

Chowkidar, attendants, servants and other officials or employees and persons in permanent, temporary or special service in connection with the work of the trust, trust estate, trust funds, and trust properties as they may from time to time think fit and to determine their power, and duties and fix, their salaries, bonus or emoluments and to require security in such instance and such amounts as the trustees may think fit. The trustees shall also have power to found and maintain provident funds, gratuity funds, personal and other funds for any employee and make rules and regulations regarding

- 5) The trustees shall have power in general to acquire all things and do all acts necessary to carry out the objects of the trust. Further, the trustees may pay out such stipends and scholarships and on such terms, if any as they may deem fit as may be commensurate with the income of the subject matter of the trust.
- The trustees shall be entitled to reimburse themselves out of the trust estate all expenses incurred in or about the execution of the trust of the powers herein or in carrying out the trust, its objects and affairs or the realization preservation or benefit or the trust properties. The trustees shall be entitled to be indemnified by the trust properties, against the consequence of all lawful acts done by the trustees in the course of and all costs, charges and expenses thereof and discharge of their duties as the trustees of these trusts.
- -Trustees shall be entitled to only remuneration commensurate with their working hours qualification 7) and duties assigned, the trustees can waive their salaries out of their own wish and can work in an honorary capacity. They shall, however, be entitled to receive the out-of-pocket expenses incurred by them in the course of discharging the trust.
- 8) The trust shall be governed by managing committee on day to day basis. The Board of Trustees shall consist of all the trustees the number of which shall always be not less than two and not more than
- 9) The trustees may elect from members of board as the President, Vice President, Secretary, Joint Secretary, Treasurer and Coordinator. The terms of managing committee initially will be for a period of two years and extendable upto three years by the trustees and approval of the managing committee. The post of patron is forever and will not be subject to any elections. The managing committee will nominate any patron if required.
- The Board of Trustees is hereby authorized and empowered to nominate any other person as life 10) member to assist them in running of the trust, as long as the life member do not exceed three in number subject to the qualification imposed. The life member should not suffer from any disqualification as applicable to the trustee. Every life member shall donate at least Rs. 1100/- towards the corpus of the trust. The number of life members can be increased by majority passed resolution of
- The trustees may at any time invite and receive or without such invitation receive any voluntary 11) contribution or contributions either from the Settlor or from the trustees or from any one or more of them or from any other person or persons by way of donation, legacy or otherwise. All such contributions shall be treated as forming part of the trust fund being the subject matter of these presents provided that it shall always be for he trustees in their absolute discretion to decide whether to invite and/or accept any such contribution without giving any reason for such refusal.

The board of trustees are authorized and empowered to nominate two patron trustees. The tenure of the patron trustees shall be for three years and extendable subject to board of trustees approval. Patron shall not be having voting right.

The trustees shall have power to deposit the trust moneys or any portion thereof in any Nationalized 12) Bank or Banks either by way of fixed deposit or in current account or saving account. The operation of bank account will be done by any two from either of the appointed President, Secretary and Treasurer. The President shall have the authority to delegate the power of bank operations to any other person or

trustee through a Power of Attorney. The delegated person will Act on the advise of the managing trustees and its power to operate bank can be removed by the resolution of the majority trustees.

- The trustees shall also have power to invest the trust money in Govt. Securities or in any other approved manner and also to invest in such manner as may be directed by the Board of the trustees, and from time to time vary the investment in which the trust funds may be invested.
- The trust moneys shall not be invested with any private individuals or firms or association of persons or body of individuals. The Trust shall make all its investments in modes specified in section 11(5) of the Income Tax Act 1961, or as prescribed in amendments to the said Act/or applicable act at that time.
- For the purposes of carrying out of the objects of the trust, the trustees shall have power to acquire by purchase or on lease or otherwise immovable properties of any tenure and in case of vacant land the trustees shall be at liberty to erect buildings thereon and to do all acts necessary and incidental thereto. The trustees shall have the power to raise loans from individuals, among themselves, private organizations, NBFCs, Scheduled banks or any other organization as approved in the meeting of the trustees. The trustees have right to nominate one person out of them to act as authorized person on their behalf for all compliances.
- 16) It shall be lawful for the trustees to pull down, renovate, rebuild, alter, adopt, improve, add to develop or repair any immovable property comprised in the trust properties and to spend thereon such moneys out of the trust fund or the income thereof as they may think fit.
- 17) The trustees shall be entitled to enter in any agreements or covenants with the owners of or persons entitled to or interested in any other properties and to raise funds by way of loans from nationalized banks and others.
- 18) It shall be lawful for the trustees at such time or times as they may in their absolute discretion think fit, to sell by public auction or private contract or exchange or transfer or assign or grant lease or sub leases for any term however, long or otherwise dispose of all or any part of the trust properties with the consent of founder trustee including immoveable properties.
- 19) The trustees may deposit for safe custody any documents held by them relating to any property belonging to the trust under these presents with any Bank and may pay any sum payable in respect of the same.
- 20) It shall be lawful and competent for the President in his discretion to make donations from the trust properties and/or send the moneys of the trust in his discretion in any other manner to carry out the objects of the trust and not contravening object clause hereinabove. Provided however, that the Board of Trustees shall be informed of the same in advance.
- The entire control, regulation, management, application and administration of the trust properties whether capital or income, rent, interest or profit of any kind shall be in the discretion of the trustees.
- Every power, authority or discretion conferred upon the trustees shall be exercised or signified either by some instrument in writing to be signed by all the trustees or such of them as may be present or by the resolution of the trustees or such of them as may be present there at any meeting of the trustees.
- In case of difference of opinion arising among the trustees and in all matters wherein the trustees shall have a discretionary power the opinion of the majority of the trustees with the consent of the managing committee shall prevail and be binding on the majority as well as on all trustees whether agreed or not. Founder Trustee will have the power to veto any resolution if he is of the opinion the same is not for the betterment of the trust.

Trustees are also empowered to take any decision in favour of and for the benefit of Trust. They have authority to appoint separate managing committee for the institutions under the trust.

## 25) MEETING:

- 1) The meeting of the Board of Trustees shall be held at least once in three months but any number of other meetings may be held as and when considered necessary
- ii) The President will preside over the meeting and in the absence of the President meeting will be presided by the Vise President.
- The trustees may meet for the dispatch of business, adjourn and otherwise require their meetings as they deem fit.
- Save as otherwise expressly provided in these presents, question arising at any meeting of the trustees shall be decided by mutual consent. In case of difference of opinion the opinion of founder trustee will prevail.
- v) The continuing trustees may act notwithstanding any vacancy in the office of trustees, if and so long as their number if reduced below the quorum fixed in these presents, the continuing trustees or trustee may act for the purpose of increasing the number of trustees to that fixed for the quorum but for no other purpose.

## 26) QUORUM:

- No business shall be transacted at any meeting unless a quorum of members is present at the time when the meeting proceeds to business.
- Save as herein otherwise provided To Two of total trustees shall be quorum. One of whom must be the President or Secretary.
- iii) If within half an hour from the time appointed for holding the meeting a quorum is not present, the meeting shall stand adjourned to the same day in the next week, at the same time and place.
- iv) If at the adjourned meeting, a quorum is not present within half an hour from the time appointed for the meeting, the members present be quorum but presence of managing President or Secretary is compulsory for the conduct of the meeting.
- A minute book shall be kept by the trustees, Minutes of the entry into office of every new trustee and of all proceedings of the meeting of the Board of Trustees shall be entered in the minute book. And shall be signed by the Chairman of the meeting either at the conclusion thereof or at the next meeting or when they shall have been fully comprised.
- Proper and regular books of accounts of all accounts of all receipts and expenditure of the trust shall be maintained by the trustee either in the Hindi language or in English or partly, Hindi and partly in English.
- On the 31st day of March every year a general account shall be taken of all the assets and liabilities of the trust and an income and expenditure account for the whole year and a balance sheet as on 31st March shall be prepared and shall be passed by the trustee. The account of the trust shall be audited annually by a firm of Chartered Accountants appointed by the trustees for the purpose.

### 30) WINDING UP THE TRUST

If upon the winding up or dissolution of the Trust those remain after satisfaction of all its debits and liabilities, any property, whatsoever and wherever, the same shall not be paid or distributed among the Trustees of the Trust, but shall be given or transferred to some other Trust/institution having objects similar to the objects of the Trust to be determined by the Founder Trustee of Trust.

The Settlor has invested the trustees jointly with the ownership and possession of the subject matter of the trust, who have agreed to accept the trust.
